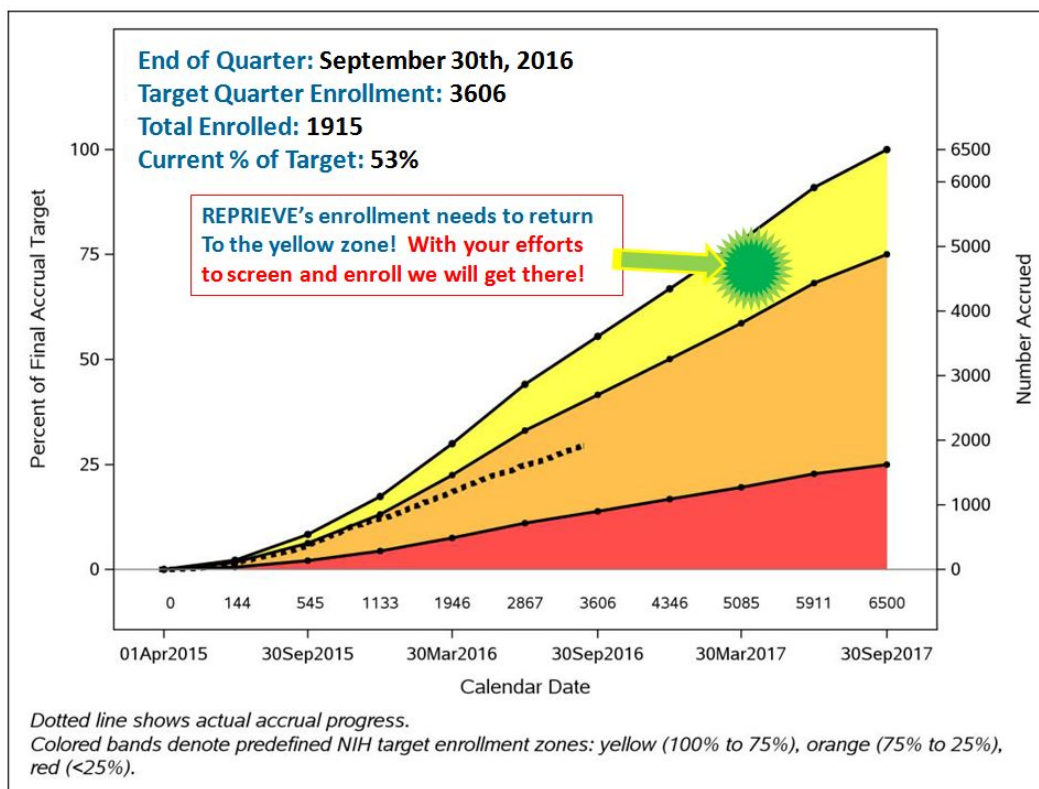

### Enrollment Updates

Thank you to every site enrolling participants in REPRIEVE. With your help, **1915 participants are now enrolled in REPRIEVE!** There are **90** sites currently enrolling, **2673** total screenings, and **180** potential participants in screening.

**If 50 participants are enrolled each week, REPRIEVE's enrollment will tip to 2,000+**

**in only two weeks, this is a huge accomplishment. We can make this happen!**

## Meet New Members of the MGH Data Coordinating Center/Mechanistic Substudy of REPRIEVE Team!



**Lisa DiGianni, PhD** is the new Project Manager for the MGH Data Coordinating Center/Mechanistic Substudy. She is a seasoned social scientist researcher with over 20 years experience directing research programs and operations. She was a Senior Research Scientist in the Center for Cancer Genetics and Prevention at the Dana-Farber Cancer Institute in Boston. She was also Principal investigator for a research program focused on complementary medicine and physical activity interventions for women at hereditary cancer risk, and has published several academic articles in this field.



**Katie Regan, BA** is a Clinical Research Coordinator and is responsible for image processing for the Mechanistic Substudy. Image processing involves the QA/QC of all REPRIEVE Substudy CT scans and communication with study sites to ensure the receipt of all needed images. Katie also writes a CT Summary Report for the substudy each week in order to outline enrollment, QA/QC patterns, and incidental findings. Additionally, she is responsible for assembling adjudication packets for REPRIEVE (A5332).

## Don't Forget! Assessing for Adjudicated Events is Essential in REPRIEVE!



It is important in REPRIEVE that all adjudicated events/REPRIEVE MACE are captured. Don't forget to complete the Adjudicated Events Tracking CRF (TRK0150) at every visit post screen.

The team has developed [this tool](#), located in the Protocol Training folder on the REPRIEVE (A5332) PSWP. The tool contains descriptive terms for adjudicated events and may be helpful when completing the Adjudicated Events Tracking CRF.
